I have reframed and repositioned Ekpe, and its sister group Mgbe, as African communication societies.

TEACHING EXPERIENCE

During my time at the University of Missouri, I have taught many of the upper division At the University of Missouri. I teach four classes each semester which include sections on Communication Competencies for a Diverse Workplace (COMMUN 4478), Political Communication (COMMUN 4473), Culture as Communication (COMMUN 3470), and Research Methods (3442). Since Mizzou is attempting to expand its communication course offerings, I asked J. Brian Houston, our departmental chair, asked if I could create a new course entitled Black Speak: Communication Among the African-Descended (COMMUN 3701) as a Special Topics class. We have offered the class since the spring of 2020. Many other communication studies programs have a "Black Rhetorical Styles" course in their catalogs, but this was a first for Missouri. I greatly expanded the ordinary subjects covered in this type of class. Because of this, my syllabus includes investigations of the birth and growth of hip-hop/rap music, the Black athlete, regional "Black speaks" (New York City, Philadelphia, Baltimore, Chicago, Atlanta, and Los Angeles),

Krio/Upper Niger linguistic connections, Hollywood/Nollywood/Ghallywood, Blaxploitation films, and the Gullah/Geechee of the American Lowcountry South.

In the fall semester of 2022, I revived the department's undergraduate Nonverbal Communication (COMMUN 3441) course, which had been dormant since 2016. My version of this class includes little-known information on nonverbal systems in places like Nigeria, Cameroon, Sierra Leone, and Mali. I have taught at Missouri since 2019; before that, I was part of the Africana Studies faculty at the University of Tennessee.

During the fall of 2021, I modified our COMMUN 3470 course to meet the College of Arts and Science Diversity Requirement through its intentional and intensive focus on areas such as the study of stereotypes, prejudice, discrimination, ethnocentrism, intercultural relationships, and intercultural communication. The class now teaches students various methodological approaches and accommodation theories that focus on concepts such as "race," class, the hierarchy of status, social inequalities, Foucault and notions of power, and interpretations of human communication styles. Missouri is dedicated to the principles of diversity, inclusion, and equity in teaching and learning. During spring 2023, I will work to bring COMMUN 3441 and 4478 into compliance with the diversity requirement.

As a Lecturer of Africana Studies at the University of Tennessee in Knoxville (UTK), I taught the African American and African studies introductory courses from 2016 through 2019. At this time, I began working on two communication studies textbooks scheduled for publication by Cognella Academic Publishing in 2024 and 2025. The first is entitled *Nsibidi*:

The Markings and Movements of Ancient Africa. Each offers a rhetorical and intercultural examination of Nsibidi, an ancient West African system of nonverbal communication. Ekpe and Mgbe practitioners among Efik, Efut, Qua, and Igbo communities in the Lower Niger River tributary region of Nigeria and Cameroon still utilize Nsibidi after four thousand years. The second book, An Anthology of The Markings and Movements of Ancient Africa: Nsibidi in the New World, will feature a foreword by Molefi Kete Asante, one of the most influential African American communication scholars of the past fifty years. I will demonstrate the influence of Ekpe/Mgbe and Nsibidi in areas of the American South where there is evidence that they survived the Middle Passage voyage and became part of plantation life and culture. Next, I wanted the committee to know that I have long viewed myself as a public scholar committed to being a voice for the marginalized. Because of this, I work with several local scholars in Maryland, Virginia, West Virginia, South Carolina, and Georgia.

While at Ohio University, I lectured sections of Intercultural Communication, Techniques in Interviewing, Fundamentals of Communication, and Public Speaking.
